ACCOUNTS:

- Accounts unpaid after 45 days are liable to be refused supply.
- We reserve the right to change interest at 2% per month on any monies outstanding 60 days or over.

RETURN OF GOODS:

- Goods will only be accepted for credit if returned to ELECSPESS Pty Ltd, in original packaging and condition, within 21 days of invoicing, showing:
 - Invoice Number
 - Date of purchase
 - Description of goods
 - A restocking fee may apply

WARRANTY:

- All parts distributed by ELECSPESS Pty Ltd are guaranteed against defective material or workmanship.
 - Failure of damage arising from faulty or incorrect fitting will not be warranted by ELECSPESS Pty Ltd.
 - ELECSPESS Pty Ltd disclaims any liability for labour costs or other damaged parts due to failure of parts supplied by ELECSPESS Pty Ltd or subsidiaries.
 - All goods sold carry the warranty of the individual manufacturer or re-builder.
 - In compliance with normal trade practices, we reserve the right to adjudicate on behalf of the manufacturer or re-builder.
 - Wherever possible, the individual manufacturer's or re-builder's warranty policy will be adhered to.

WARRANTY PROCEDURE:

- Goods must be returned, freight pre-paid, to our warehouse showing:

 - Proof of purchase
